

Grey Literature Resources

Grey literature is a term for publications produced outside of usual commercial and academic channels. Searching Grey Literature is part of completing a systematic review. Below is a selection of sources for identifying clinical trials, government documents, conference proceedings, dissertations and theses, and other reports. Resources are freely available to all online unless noted by an asterisk, in which case they are available through library subscription.
